The Series A Preferred Stock has no expiration date.
- 25% of the shares subject to the option vested on 1/27/2021, and 1/48th of the shares subject to the option vest monthly thereafter.
- 1/48th of the shares subject to the option vest monthly following March 5, 2021, the vesting commencement date.
